



## REQUIREMENTS FOR THE IMPORTATION OF HOUSEHOLD GOODS

- Having been outside of Argentina for at least 1 year, and being able to prove it by means of a **Certificate of Residence**.
- Not having been in Argentina for more than **60 days (in total)** in the 365 days prior to the final return.
- Not having been in Argentina for more than **180 days** after the final return.
- Not having imported household goods to Argentina in the **last 7 years**.

### REQUIRED DOCUMENTATION FOR RETURNING CITIZENS AND PERMANENT RESIDENTS

- **Photocopy of all pages of the passport used to enter Argentina.**  
Requires authentication by notary public and Association of Notaries in Argentina.
- **Photocopy of the Argentine ID (front & back) with updated address (If you don't have an updated ID, add address certificate).**  
Requires authentication by notary public and Association of Notaries in Argentina.
- **CUIL/CUIT certificate.**
- **Migratory movements from current and previous year.**  
This procedure can be done through our agent (USD 100) or through this LINK.
- **Authorization for customs clearance** (This document is given to you by your Elishar Moving Agent).  
Requires authentication by notary public and Association of Notaries in Argentina.
- **Residence certificate** (Only if the owner of the shipment was more than 60 days in Argentina on the **365 days prior to return**).  
Issued by the Argentine consulate in the country of origin.
- **Letter of guarantee** (Only if the shipment is entering on an **exclusive container**. This document is given to you by your Elishar Intl. Movers agent).  
Requires authentication by notary public and Association of Notaries in Argentina.

## REQUIRED DOCUMENTATION FOR TEMPORARY RESIDENTS

- **Photocopy of all pages of the passport used to enter Argentina.**  
Requires authentication by notary public and Association of Notaries in Argentina.
- **Photocopy of the argentine ID (front & back)**  
Requires authentication by notary public and Association of Notaries in Argentina.
- **CUIL/CUIT certificate.**
- **Migratory movements from current and previous year.**  
This procedure can be done through our agent (USD 100) or through this LINK.
- **Authorization for customs clearance** (This document is given to you by your Elishar Moving Agent).  
Requires authentication by notary public and Association of Notaries in Argentina.
- **Documentation that certifies temporary residence.**
- **Surety insurance.** It must be valid until the repatriation of the goods or until their nationalization.
- **Letter of guarantee** (Only if the shipment is entering on an **exclusive container**. This document is given to you by your Elishar Moving Agent).  
Requires authentication by notary public and Association of Notaries in Argentina.



# PROHIBITED AND LIMITED ITEMS

## PROHIBITED ITEMS

- **Drugs & narcotics.**
- **Ammunition and other flammables.**
- **Industrial machinery.**
- **Motorized vehicles that are not cars or motorbikes.**
- **Food and other organics.**
- **Money.**
- **Commodities.**
- **Autoparts.**
- **Pornographic material.**

## LIMITED IMPORTATION ITEMS

- **Firearms.** They must be declared and authorized by the RENAR.
- **Fossils and ivory.** Requires authorization according to Argentine law.
- **Wood.** Requires phytosanitary treatment prior to shipment in accordance with ISPM 15 measures.
- **Alcohol bottles.** Up to 30 liters or 8 gallons.
- **Artwork (applies to selfmade, recognized and unrecognized).** They require authorization, for which the following information is needed for each work: photo of the front and back; name of the author and if he/she is alive, technique (oil, watercolor, etc.); material (canvas, wood, etc.).

In case of having a limited item, please notify your Elishar Moving Agent for proper authorization. **Failure to do so will result in the item being removed from the shipment.**
